

4. The amount of Security Deposit deposited shall be adjusted from the total amount of payment due from the successful bidder. The successful bidder must make the balance payment within three working days from the date of auction. Failing which, 0.5% will be charged per day as penalty on the full amount.
5. If the highest bidder is unable to deposit required amount within stipulated time, the Security Deposit amount deposited by the firm will be forfeited and contract will be cancelled.
6. If the highest bidder refused to accept the order, then the offer will be given to the second highest bidder to accept the auction with the amount quoted by the highest bidder, if the second highest bidder will agree.
7. The Security Deposit of remaining unsuccessful bidder will be returned to them, without interest after finalization of sale/auction to the successful bidder.
8. There should not be any temporary or permanent structure constructed in the orchard area. If any such structure is raised, the contract will be cancelled. No refund will be made.
9. No items, once disposed of from the successful bidder shall be taken back by this office on any condition whatsoever. Any uncleaned or unnoticed materials/items left over by the purchases within the premises cannot be claimed later.
10. The bidder should conduct due diligence on all aspects related to the property to his satisfaction.
11. The bidder shall not be entitled to make any claim against the authorised officer in this regard at a later date.
12. The items shall be sold/auctioned to the highest bidder.
13. The highest bidder should pay 1/3rd of the amount of the quoted price on the same day as security deposit and the balance amount within three working days from the date of issue of bid acceptance letter.
14. The produce once auctioned cannot be taken back or exchanged.
15. The produce will have to be properly saved from birds etc. and picked by the highest bidder without any permanent damage to the trees at their own cost and remove with their own means. The ICAR CIWA shall not be responsible for any loss damage or pilferage to produce. The highest bidder will however be permitted to keep guard for the period specified against the produce with intimation to the Security Officer of this Institute.
16. There should be no damage to the experimental material or fencing of the boundary etc., in case there is any damage, the bidder will bear the cost of damage with complete details.
17. Any tax if leviable shall have to be paid by the successful bidder.
18. Produce except Mango and Sapotas, will not be allowed to be removed. In the case the successful bidder or his worker is found doing so the contract will be nullified and the money deposited for the purpose will be forfeited.
19. The contract will not use any spray or other treatments of trees for experimental purpose.


20. Cooking food in the ICAR-CIWA premises will not be allowed in any case. If any worker is found doing so the contract will have to pay the penalty as deemed fit.

22. The material/Mango and Sapotas should be cleared away from this office premises within the stipulated date i.e. by 30.05.2026. There should not be any damage to the property of this institute / inconvenience in functioning.
